9. You must visit the fair and collect customised stamps from the "Buying Mission Service Counter" in order to be qualified for the incentive. **Only 1 stamp can be collected on each fair day.**
10. **The original copy of the acknowledgement letter, passport with landing slip, business card, boarding pass and e-ticket receipt MUST BE presented upon the reimbursement collection. HKTDC reserves the right to reject any reimbursement requests should there be any informational discrepancies on the passport, landing slip, boarding pass and e-ticket receipt.**
